Information for personal data processing as per article 13-14 of EU GDPR Regulation 2016/679

The personal data shall be processed pursuant the regulation as per Decree Law no. 196, 30 June 2003 and as per EU GDPR Regulation 2016/679 "General Data Protection Regulation".

1) THE DATA CONTROLLER

The controller of processing of personal data is ALiSEO – Via S. Vincenzo, 4 16121 Genova – Phone 01024911

2) PURPOSE OF DATA PROTECTION

The personal data are processed for the purposes connected to the entirety of the activities, performed by information technology means as well as of hardcopy archive, aimed at drawing up a list of students applying for accommodation as provided by Regional and National regulations on the subject of the Right to University Education.

3) COMUNICATION OF THE DATA

The processed data (personal data, address, email address, university enrolment data, etc.) may also be disclosed to Liguria Region, to the Università degli Studi of Genoa, to the Institutions for Higher Education in Art and Music (AFAM), to the Italian Agency of Revenue (Agenzia delle Entrate), to the Ministry of Education, University and Research, to the Ministry of the Interior, to the Ministry of the Defense, to the National Association of the institutions for the Right to University Education (ANDISU), as well as to other public authorities or private subjects that cloud carry out control, statistics or research activities.

In the frame of processing them for any procedures related to institutional compliances, personal data may be accessible to those that, within ALiSEO organization, have the task to process them (ALiSEO personnel, employees) as well to third parties who have to process them behalf ALiSEO and to the ALiSEO information technology personnel.

4) DISCLOSURE OF PERSONAL DATA

Disclosure of personal data for the purposes defined at point 2) is mandatory; failure to comply will result in exclusion from the assignment of the accommodation.

The data processed are the data disclosed by the student at the time of presentation of the accommodation application form.

5) STORAGE TIME OF PERSONAL DATA

The data collected, except for different resolutions of Liguria Region or of the Ministry for University and Research, will be kept for ten years and appropriate safety measures shall be taken in particular against accidental loss or unlawful destruction, alteration, unauthorized disclosure of, or access to personal data transmitted, stored or otherwise processed.

6) RIGHTS OF THE INTERESTED PARTIES

As far as data processing is concerned, the interested parties have the rights granted as for articles from 15 to 22 of GDPR Regulation (EU) 2016/679.
